This Month in Emergency Communications: Heat Related Preparedness

While definitely decreasing in frequency, summertime brownouts and blackouts have been a problem for many communities due to heightened demand on the electrical power grid as consumers try to stay cool. Heat waves can further increase the likelihood of a systemic overload. Heatwaves are also frequently followed or punctuated by thunderstorms that are stronger than usual.

These notes as we head into the hottest days of the summer are meant to highlight the need to test and verify our capabilities to meet the needs of our served agencies without the advantage of commercial power. Operators should make sure off grid power systems are still viable and safe to operate should the need arise.

Monthly Net Report

The July communications test night seemed pretty sparse for checkins. This is likely due to people being out and enjoying the summer holidays. For the nets, a total of **28 check-ins** were noted across the four sector nets many of whom were RACES stations.

Three of the four nets were run with Net Control Operations being handled by Region 2 Headquarters operators (WC1MAB) and the Sector 2D net being handled by Don at WA1PLE which is our normal operating posture for the monthly net.

Region 2 HQ did not participate in the monthly HF net due to the dipole antenna being out of service. The MEMA communications shop has been made aware of the issue and have been working on procuring a replacement antenna. It is expected that the HF capabilities will be back in service before the end of the summer.
