## This Month in Emergency Communications: MEMA and FEMA Offered Training

The emergency management landscape is constantly changing and evolving. As emergency communicators, RACES volunteers should always be striving to improve their capabilities and understanding of emerging communications technologies as well as changes to the response plans and tactics of their served agencies. There are many ways to keep skills fresh including participation in the monthly RACES/EMCOMM nets, participation with local ARES groups and attending meetings held by your local Emergency Management Agencies. Another option that is available for continuing training is through courses offered by FEMA and MEMA. FEMA offers independent study courses in various emergency management areas. MEMA also has training opportunities throughout the Commonwealth. These training sessions often give priority selection to full time and part time emergency personnel who may require the training for certification in their career paths. Through coordination with your local EMD, open slots are occasionally allowed to be filled by local emergency management volunteer staff which should include duly appointed RACES Radio Operators.

#### **Monthly Net Report**

The October communications test night had a solid number of checkins. To get a better idea of the distribution of RACES Stations in our region I have included a map graphic showing the checked-in RACES stations. I am hoping to have more useful plots like this moving forward as I better learn the GIS programming command sets.



Three of the four nets were run with Net Control Operations being handled by Region 2 Headquarters operators (WC1MAB) and the Sector 2D net being handled by Jeff, N1JCM which is our normal operating posture for the monthly net.

Region 2 HQ did not participate in the monthly HF net due to the dipole antenna being out of service. Work continues on getting a replacement HF antenna up and running, however there is no longer any ETA on this work being completed at this time.
